- C) First Party & Second Party believe that collaboration and co-operation between 4 themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.

CLAUSE 2

SCOPE OF THE MOU

- 2.1 Seminars/ Conferences/ Workshops/Lecture Programmes: Both Parties may jointly organize National/International/State level seminars/conferences/workshops/lecture programmes to develop requisite skill amongst current students and alumni.
- 2.2 Various Online/Offline skill development Courses may be organized for the students by both the Parties in collaboration.
- 2.3 Trainings/Workshops and Placement: The two Parties may conduct useful technology and skill-based training programmes for students of school and college levels. The training programme will be conducted mainly on Information Technologies Enable Service (IDES -BPO Training), Customer Relationship and Sales (CRS), Banking Financial Services and Insurance (BFSI). After completion of the said training, the placement assistance will be offered too.

CLAUSE 3

VALIDITY

3.1 This Agreement will be valid for a period of Five (5) years and will require the approval of the Executive Committee for further extension.

CLAUSE 4

RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership and no commercial terms are involved herewith.
